





Principal Investigator's profile

Research experience

- a. PhD holder upload a scan of the PhD diploma in the online submission system (OSF)
- b. no PhD upload documents confirming at least 4 years of full-time research experience (e.g. a declaration signed by a representative of an institution where the research was carried out)
- c. at least one publication published or accepted (upload a scan in the Academic Track Record section)
 - if the original documents confrming research experience were not drawn in Polish or English, upload the originals and a translation into Polish or English
 - count the 4 years from the date you you obtained a degree which formally entitles you to start on a doctorate (e.g. MA, MSc) in the country where the degree was obtained or in Poland
- not sure if your diploma or degree is recognized in Poland?
 - ask the Host Institution

 - NCN does not require diploma nostrification, but it may be necessary to sign the job contract

Researchers at risk

- Researchers who are experiencing threats to their life, liberty or research career, and those who are forced to flee or have been displaced because of such threats, are encouraged to apply.
- Time spent in Poland as part of procedure for obtaining refugee status under the 1951 Geneva Convention and 1967 Protocol does not count towards 12-month limit imposed by the mobility requirement.
- Time spent in Poland and/or employment in Poland after 24 February 2022 does not count towards 12-month limit for researchers who left Ukraine as a result of war and are eligible for temporary protection under Council Implementing Decision (EU) 2022/382 of 4 March 2022.

NCN has also simplified the eligibility check for refugees from Ukraine without relevant documents.



Principal Investigator's profile

PI makes a commitment to:

- ✓ reside in Poland for the entire project funding term and be available to the Host Institution. The obligation does not apply to documented foreign business trips related to the project, field research abroad and holidays, time off work and other excused absences governed by generally applicable laws.
- ✓ participate in at least three 2-day training courses on transferable skills, organised and paid for by the NCN
- ✓ carry out an intersectoral secondment phase outside of the Host Institution (14 days minimum see Guide for Applicants p. 21).

During the funding term the PI makes a commitment NOT to:

- □ use any other sources of funding their arrival or stay in Poland
- ☑ participate in any international mobility, except to carry out the project research and training tasks under POLONEZ BIS
- ☑ receive any other salary from funds allocated as direct costs under research projects funded in other NCN call
- ⊠ receive any salary from another employer pursuant to an employment contract, including an employer with a registered office outside of Poland



Ineligible Applicants

- a. Researchers previously funded as POLONEZ or POLONEZ BIS Fellows
- b. Researchers who were Principal Investigators in a research project carried out at a Polish institution (funded by NCN or other funder) between 15 September 2019 and 14 September 2022
- c. Researchers who applied as PI in any other proposal submitted to NCN in answer to any call launched on 15 September 2022, or in answer to previous NCN calls if their proposal received a funding decision which remains in force, or is still under evaluation, or is under appeal
- The Applicant cannot sign the proposal on behalf of the Host Institution.
- You may resubmit a proposal which was rejected in POLONEZ BIS 2. Pay attention to the dates a rejection decision remains in force for 14 days and can be appealed by the applicant. The applicant may waive the right to appeal in an official letter to the NCN Director. If your proposal to another call was rejected, check who was the applicant if the institution was the applicant, the institution must sign the waiver.
- If you have submitted a proposal to another funder in Poland or abroad, and it is still under evaluation, you may apply for POLONEZ BIS but if both proposals are funded, you will have to choose which one you will carry out.



Host Institution profile

All legal entities with a registered office in Poland are eligible as POLONEZ BIS host institution, regardless of the sector they represent.



The proposal should describe only one Host Institution (Participating entity) which will employ the POLONEZ BIS PI. The PI may cooperate with more than one institution in Poland or abroad e.g. during short-term secondments. Cooperation with institutions located in the Russian Federation is not allowed.

Host Institutions must provide additional documents if

- they do not belong to the public finance sector
- they do not receive any institutional core funding for research
- POLONEZ BIS funding will constitute state aid for them



Host Institution profile

- The profile of the selected Host Institution should reflect the nature of the research project as well as the PI's profile and professional goals set in the Career Development Plan.
- The hosting arrangements should be described in the Host Institution Capacity Form.
- The proposal should name only one Mentor who was already an employee of the Host Institution at the date of the call launch and whose research track record is described in detail in the proposal.
- The Mentor's experience and expertise should be relevant to the research field and the PI's career stage. There are no formal requirements as far as the degree/title of the Mentor.



Host Institution profile

During the funding term the Host Institution commits to:

- ✓ employ the Principal Investigator for the entire POLONEZ BIS fellowship funding term based on a full-time employment contract, exclusively for the implementation of the project research and training tasks and in compliance with the <u>European Charter for Researchers and Code of Conduct for the Recruitment of Researchers</u>;
- ✓ employ the Mentor throughout the entire fellowship funding term, based on an employment contract. The Mentor's contracted working time should be sufficient to allow for adequate supervision of the project and mentoring of the PI;
- ✓ provide the Principal Investigator with free full access to facilities, infrastructure and/or equipment necessary to carry out the research tasks described in the proposal;
- ✓ appoint or employ an administrative officer with fluent command of Polish and English, who will help the PI at the relocation stage and with administrative and financial issues during the fellowship. The minimum working time of the administrative assistant should be 0,25 Full Time Equivalent;
- ✓ reach an agreement with the Principal Investigator on how to use at least 25% of the other indirect costs;
- ✓ support the PI in promoting their research outputs, open access publishing, and data management.



Ineligible Host Institutions

A Host Institution is ineligible if:



it employed the PI within 3 years before the proposal **submission deadline** i.e. between **15 December 2019** and **15 December 2022**.

The proposal includes the PI's declaration regarding their previous or current employment in the Host Institution.



it granted the PI the PhD degree **unless** since the PhD award the PI completed a documented postdoctoral fellowship(s) outside Poland, lasting a total of at least 3 years, including at least one postdoctoral fellowship lasting an uninterrupted period of 12 months.

Post-doctoral fellowships should be listed and documented in Part 2 of <u>Compliance with the eligibility</u> <u>criteria</u>



- a checklist of all documents to be uploaded in PDF is included on page 14 of the Guide for Applicants.



Basic research is defined as experimental or theoretical endeavours undertaken to gain new knowledge of the foundations of phenomena and observable facts, without any direct commercial use.
















Experts:

- experienced researchers (mainly from outside Poland) selected by the NCN Council,
- o represent different disciplines, not necessarily specialists in the subjects of the proposals,
- o prepare individual (Ist stage of the evaluation proces),
- select applications to IInd stage of the evaluation,
- select reviewers,
- conduct interviews with POLONEZ BIS candidates,
- recommend applications for funding, waiting list and preparing final justification for rejected projects
- o act according to the Code of Ethics for Experts of the National Science Centre.



- prepare individual assessments of applications (IInd stage of the evaluation proces),
- Not participate neither panel meetings nor interwievs with applicants,
- act according to the Code of Ethics for Experts of the **National Science Centre**





Experts & Reviewers



- \circ selected by the NCN Council,
- evaluate ONLY ethics issues of proposals (IInd stage of the evaluation proces),
- conduct interviews with candidates,
- act according to the Code of Ethics for Experts of the National Science Centre.



Interview

- during the second stage of the assessment,
- remotely via telecommunications tools (in English),
- duration about 20-30 minutes (10 minutes presentation + 10 minutes discussion
 with Expert Team Members and (if qualified, up to 10 minutes discussion with Ethical Experts)
- time for applicant to answer critique points from the reviews
- planned for May 2023

Information about the date of the interview and reviews will be sent within 14 days in advance.





Results in POLONEZ BIS 3 call

- Ranking list will be published no later than in the first half of June 2023
- In the case of resignation from funding by candidates on the ranking list, applications on the waiting list will be funded
- Applications that do not receive funding in POLONEZ BIS 2 might be re-submitted in POLONEZ BIS 3 call





Q&A

The order of the questions is based on their subject matter and not the order in which they were asked during the webinar.

PI'S SALARY - MOBILITY ALLOWANCE

- Q Which positions does "mobility allowance" include? Is mobility allowance necessary, if I change the country of living? Is this money only for a travel from your home country to Poland or for a travel to a second institute and conference?
- A Mobility allowance is an element of the salary of the POLONEZ BIS Principal Investigator. Together with the living allowance, it will be paid as a lump sum to all POLONEZ BIS Fellows. You cannot decide not to claim it it will be automatically pre-filled in the proposal budget. The aim of this allowance is to compensate the PI for the differences in the cost of living after moving to Poland as it is obligatory for all funded PIs to move to Poland for 2 years.

The decision how the Fellows spend their salary depends entirely on them. The NCN never asks PIs to report what their salary was spent on.



PI'S SALARY - FAMILY ALLOWANCE

Q Can the family situation be updated after the project has been approved? E.g., if kid will not be born by the application deadline, can family allowance be requested later? Does family allowance apply even if the applicant's spouse gets a job in PL? (1 child)?

I'm divorced from 2014. I live from 2015 with my ex- husband and we 'would like to be together if I'm wining the scholarship. Can he be elegible to profit from the family mobility allowance?

A Eligibility for family allowance is determined at the call submission deadline and will not be revised during the fellowship. The payment of the family allowance depends on the Pl's declaration in their proposal that their spouse/partner and/or child/children will relocate to Poland together with them for at least 3 months during the project funding term. You can still apply for the family allowance if your spouse/partner is planning to get a job in Poland, if you are expecting the child to be born after the application deadline. The NCN does not ask the Fellows to provide birth certificates, or any documents that confirm your marital/partnership status. All you need to do is answer a Yes/No question in the proposal - if your spouse/partner/children will join you in Poland for more than 3 months during the implementation of your project.



- Q Does the Diploma of Candidate of Sciences (adequate to Dr) obtained in Ukraine in 2008 have to be nostrificated for POLONEZ BIS 3 or it is sufficient just to copy and translate it?
- A NCN does not require diploma nostrification at the proposal submission stage, so it is enough to upload a copy and its translation into Polish or English. During the formal eligibility check the NCN will accept the Diploma of Candidate of Sciences as equivalent to PhD. Nostrification may be may be necessary to sign the job contract. If you not sure if your diploma or degree is recognized in Poland, please ask your Host Institution and/or use the Kwalifikator system available in Polish and English on the website of the Polish National Agency for Academic Exchange https://nawa.gov.pl/en/recognition/system-kwalifikator.
- Q Would you accept applicants who will not have a PhD upon submission but upon the start of the project?
- A Yes, if you do not have a PhD degree by 15 December 2022, you can apply as a person without the PhD but you will have to document at least 4 years of full-time equivalent research experience this could be a doctoral programme, work done on a research project etc. Scans of supporting documents confirming such experience have to be uploaded in the electronic submission system. If the supporting document was issued in a language different from English or Polish, provide its translation to English or Polish as well.

If the project is granted and by then you already have your PhD, you will be able to change your data in the electronic submission system (OSF).



- Q Is a previous CoFUND fellow eligible to apply? Can a previous H2020-MSCA fellow become eligible for this call?
- A Yes, if it was a co-fund different from POLONEZ or POLONEZ BIS programmes and if that co-fund project was not carried out with a Polish institution. Generally, if you meet the other conditions (experience, mobility), you should be eligible.
- Q Can the previous Lane Kirkland Program Fellows to apply for POLONEZ BIS 3?
- A Yes, you can apply for POLONEZ BIS 3. Generally, if you meet the other conditions (experience, mobility), you should be eligible.



Q Is it possible to apply to POLONEZ BIS 3 and later apply to another NCN scholarship (such as Sonatina)?

A Yes, it is possible. In fact we encourage you to apply for other NCN grants as follow-up to POLONEZ BIS. It takes time to get the next grant so hopefully your POLONEZ BIS and another NCN grant will not overlap. If they do, you will not be able to get the full-time salary from both grants. But you can always apply.

All NCN proposals ask about similar research tasks in order to eliminate any double funding – tasks that are or were funded by the NCN or from other sources must not be submitted to any call. In some cases, however, the study protocol may require some tasks to be repeated – it is best to consult specific cases with the mentor at the host institution and then list such tasks with the explanation why they need to be funded.



- Q Can I apply for POLONEZ BIS 3 if I am accepted to work at the University, which is supposed to be a host institution on October 5, 2022? Can I choose another host institution for my application?
- A If you are accepted to work on the basis of an employment contract (not a civil law contract), you will not be able to apply for POLONEZ BIS 3 at this institution.
 - You can take the employment contract at the University in October, but your POLONEZ BIS proposal will have to indicate a different host institution. Please note that if your grant is funded, you will have to change your institution because you will not be able to have two jobs at two different institutions at the same time.
- Q If I was a visiting researcher at my planned host university for 12 months from October 2021 to September 2022, but I was not employed, can I apply?
- A If there was no employment contract, generally you will be able to choose this university as your host institution. As for 12 months, if you did not stay in Poland for more than 12 months in the 3 years immediately before the date of call launch (i.e. between 15 September 2019 and 14 September 2022), you are eligible under the mobility criterion.



- Q I have a chance to start working at the host institution before the decision on grant proposal will be available (but after the application deadline). Will I be able to continue working at the host institution if I receive the Polonez grant?
- A You will be eligible to apply with this host institution because your employment will not start before the 15 December 2022. If your employment starts later on and then you receive the POLONEZ BIS funding decision, you can continue working at the host institution but your tasks will have to change. The usual practice in such cases is to sign an annex to the previous contract of employment and devote your time exclusively to POLONEZ BIS tasks.
- Q If I recently (in April) started an adjunkt position in Poland (coming from abroad), am I eligible for Polonez and does it make sense to apply??
- A You are eligible if you have not resided, studied or been employed in Poland for more than 12 months in the last 3 years before the call launch (i.e. between 15 September 2019 and 14 September 2022). If you have only been in Poland since April 2022, there is no mobility issue. However, your present employer cannot be your POLONEZ BIS host institution.



Q I am 72, retired Professor Emeritus. Does it make sense to apply?

A You can still apply because there is no age limit in the POLONEZ BIS programme. The Call is addressed to researchers at any career stage, regardless of age. Applicants are required to hold a PhD degree or at least 4 years of full-time, documented research experience. However, you have to consider the Career Development Plan and the fact that experts are going to look at how the grant will impact on your future career. This might be more challenging for a researcher with a well-established position in the scientific community. On the other hand, a researcher with greater experience will be able to demonstrate more impact in another evaluation criterion, concerning mutual gain from transfer of knowledge and expertise between the host institution and the applicant. In any case, it will be up to the experts and reviewers to make the final decision during the evaluation process.



- Q I finished my PhD in 2010. I was doing research until 2017. Since then I am a teacher and want to come back to research. Am I eligible for POLONEZ BIS 3?
- A You meet the experience requirement you are a PhD holder. You are eligible if you also meet the mobility requirement (you have not resided, studied or been employed in Poland for more than 12 months between 15 September 2019 and 14 September 2022), and if you authored or co-authored at least 1 research publication within 10 years before the call launch. There is a part in the proposal where you describe your CV this is where you should explain your teaching career. Also, in the *Preliminary Career Development Plan* where you describe your goals you can refer to your plan to come back to research and how POLONEZ BIS will help you to reestablish yourself as a researcher.



HOST INSTITUTIONS

- Q Do we need to select the host only from the list given?
- A <u>The list given in the call text</u> does not refer to any particular institution, it is a list of different types of institutions. The host institution must be of a type that is given in the list.
- Q Can some budget be applied for developments of the Host Institution?
- A The Host Institution can receive indirect costs of up to 20% of direct costs that may be spent on costs that are related indirectly to the research project. HI must reach an agreement with the Principal Investigator on how to use at least 25% of the amount of indirect costs actually accrued in the project. For more details read <u>Annex 3 to NCN Council Resolution on POLONEZ BIS 3.</u>
- Q Can the PI recruit co-investigators who are not members of the host institution or not living in Poland/Europe?
- A Yes, the PI can recruit co-investigators, from Poland or abroad, needed for the specific research tasks under the project. To receive payment for their work they will have to sign an agreement with the host institution.



HOST INSTITUTIONS

- Q Does the host institution have to fill out any documents related to the application process?
- A Yes, the proposal contains two documents dedicated to the host institutions: the Host Institution Capacity Form and Declaration of the Mentor. These two documents are mandatory for all host institutions. Host institutions which are not from the public sector must also complete additional documents related to <u>state aid</u>.
- Q How can I know if the requested funding constitutes state aid? Is there a free form for a declaration related to state aid rules? Shall it be submitted as additional files from the PI and the Institution representative?
- A To confirm if the funding from NCN constitute state aid, you should contact the prospective host institution. In the online proposal, if the answer to the state aid question is "no", the institution does not have to submit additional documents. If the answer is "yes" the Electronic Submission System (OSF) will generate templates of all necessary documents and provide instructions on how they should be signed. Generally speaking, NCN funding does not constitute state aid for public universities or research institutes.



ETHICAL ISSUES

- Q Could the medical project with examining of the patients take part in POLONEZ BIS?
- A Yes, all medical studies / experiments are invited to be submitted in the call, as long as they do not have a commercial use. The non-commercial character of medical trials should be explained in the dedicated section of the ethics form.
- Q "Ethical issues: Description of the measures taken to ensure that the research will be carried out in compliance with the rules of good scientific practice in the given field/discipline. Information on any permissions already issued or description of how the relevant requirements will be fulfilled." The Institute I am planning to do the research has all the permissions for scientific research, including GMO, shall apply for such permissions individually?
- A In this section of the proposal form you should include all information relevant for this project. All needed ethical permissions or approvals should be listed in this section. If a research task requires additional approvals, the proposal should include this information. In the case of doubts, please ask the prospective host institution for support.



PROPOSAL - collaboration

- Q Is it possible, under the POLONEZ BIS, to continue a participation in the collaboration/project which I am working on at current institution?
- A The answer depends on the nature of the current collaboration, e.g. if the applicant works in the institution based on the employment contract under Polish Labor Code, the institution will not be eligible as his/her host institution. In this and other similar cases we would recommend contacting us and providing more details.
- Q In case of planned collaboration with researchers within the EU, are the letters of intent required at this stage?
- A No, letters of intent are not required.
- Q Can I include the funds/salary for post-doc(s) from other countries in the proposal?
- A POLONEZ BIS doesn't have a separate post-doc position. A researcher who meets the definition of a post-doc can be hired as a co-investigator.



PROPOSAL

- Q Does the publication require that the PI was first author?
- A No, the PI can also be a co-author.
- Q How many people can be involved in one team of the project?
- A There is no fixed limit to the size of the project team. However, there is a 100 000 euro cap on other costs of research which also cover the costs of the salaries paid to the members of the project team. Please also note that the role of each research team member should be well justified in the proposal.
- Q Do I have to be in Poland at the time of application?
- Q No, you don't.
- Q Is there any proposal template for POLONEZ BIS 3 like MSCA Proposal to follow or just simply upload PDF files.
- A The call announcement shows the <u>proposal template in PDF</u>, the <u>Guide for Applicants</u> has a checklist on page 14 with the list of all sections of the proposal and information about additional supporting documents. POLONEZ BIS proposal has to be completed online in the <u>Electronic Submission System (OSF)</u>.



MENTOR

- Q Can the Mentor in POLONEZ be the PI in other project (e.g. OPUS) at the same time?
- A Yes, they can.
- Q How will Mentor's relatively low h-index (more technology oriented) impact the project evaluation?
- A The Hirsch Index is not taken into consideration in the evaluation process. NCN calls and proposals do not ask researchers to provide h-index at all. The fact that Mentor's career has been more technology-oriented will be evaluated in reference to the thematic scope of the proposal and the PI's goals described in the Career Development Plan.



Project implementation – start date

Q Can the project commence in 2024 instead of September/October/November 1, 2023?

At the proposal submission stage we ask PI's to choose between these three dates in order to calculate the salary of the PI. After the funds are granted, NCN will be flexible about changing the start date, if we receive a well motivated request. If there are research-related reasons why your project cannot start in autumn, please contact the POLONEZ BIS Coordination Team with your request.

Q After selection of grant how many days you give for joining?

A The funding decisions will be issued no later than 15 June 2023 – you will then have 2 months, to prepare, sign and send back the draft of the funding agreement to NCN. The project will start on the date indicated in the proposal.



Project implementation – PI's employment at the Host Institution

- Q I have PhD from Czech Republic (2010) and 7 years post-doc experience in 4 different countries. Which position could I have if I win the POLONEZ BIS 3? Assistant Prof. or Post-doc?
- Q What position should the PI be employed at? Post-doc? Assistant Prof?
- Q Which position is given to selected candidate, is it Post-doc fellow or Scientist?
- A NCN would normally refer to you as the MSCA POLONEZ BIS Fellow, but the name of the actual position that you are given at the host institution would depend to a large extent on its internal regulations generally, it would be a research position.
- Q Is POLONEZ BIS Fellow required to teach? Can the host institution make the fellow take up teaching duties?
- A POLONEZ BIS Fellows are not required to teach, the host institutions are not allowed to make them do anything which is not part of the research and training activities related to the project's implementation. Teaching tasks <u>may be</u> undertaken during POLONEZ BIS funding term if the Fellow feels that they develop him/her as an academic. In terms of payment, your POLONEZ BIS employment contact is solely for doing research, but if you agree to teach, you may take up some teaching and sign an extra civil-law contract for a module or two if you so choose.



Budget/eligible costs

- Q My research will require national travel around Poland as part of my field work. I am not planning on having a car, would an estimate of train/bus tickets be appropriate?
- A Yes, it is possible to plan costs of fieldwork trips (i.a. train/bus tickets) in the POLONEZ BIS Call. It should be noted that every cost planned in the proposal must be well justified with regards to the subject and scope of the proposed research and based on realistic calculations. Please remember that the budget must be drafted pursuant to the requirements specified in Annex 3 to the NCN Council Resolution on terms and conditions of the Call Costs in research projects funded by the NCN under POLONEZ BIS 3.

The eligibility of costs planned will be checked during the proposal evaluation, the costs incurred during project implementation will be checked during the evaluation of mid-term and final report and during the external control and audit.



Call – general questions

- Q If it turns that I will not win this grant, will it be possible to apply for Polones Bis 4?
- A No, we only have 3 Calls in this MSCA POLONEZ BIS grant. It is quite possible that in 2 years time we will be able to win another grant and then perhaps there will be some continuation of the programme. If you do not win POLONEZ BIS 3 grant you may always apply to other NCN's funding instruments, such as OPUS, SONATA, SONATA BIS depending on your career stage, more information on NCN funding opportunities: https://www.ncn.gov.pl/en/finansowanie-nauki/konkursy/typy.
- Q Can POLONEZ BIS fellow simultaneously or just after receiving the fellowship apply for other grants? For instance to fund additional person?
- A You may apply simultaneously for other grants as a PI yourself, but double funding of the same tasks is forbidden. Therefore, if you receive funding for the same research from other sources, you will have to decide which funding you accept. Applying to another funder at the same time will not affect the evaluation of your POLONEZ BIS proposal.
 - Co-investigators who work on POLONEZ BIS project as research team members should either be funded from POLONEZ BIS, or assigned to the grant without remuneration (e.g. because the host institution already employs them and pays their salaries from its own budget).



Call – general questions

- Q Can we check previously successful proposal open access? is there any site to check these projects?
- A NCN does not publish the entire proposals qualified for funding in its calls. An abstract for the general public is published when the call results are announced see the <u>POLONEZ BIS 1 results</u>.

After the funding agreement is signed, the basic information about each project is available in the project database, which you can filter according to selected

- project title, field panel and descriptors and keywords,
- name of the Host Institution and the PI,
- project funding term and amount of funding awarded,
- description of the project for the general public.



Call – general questions

Q How many people will be accepted into this fellowship?

A In total, for all three POLONEZ BIS Calls, we have 120 research positions to offer. We have already filled 50 in POLONEZ BIS 1, the evaluation of proposals in POLONEZ BIS 2 is still in progress, so the answer also depends on how much money we have left after we complete it. With the budget we currently have for POLONEZ BIS 3 Call (EUR 5,8 M) we should be able to fund up to 30 grants.

Q How high are the chances to get the grant in linguistics?

A Linguistics is on the list of <u>NCN panels</u> – altogether in 10 years of NCN's operation we funded over 1000 grants that put linguistics in keywords, in the previous MSCA POLONEZ (2015-2021) we had 3 grants within the linguistics area, as for POLONEZ BIS 1 we already have 2 linguistics-based projects.

Networking

- Q Is there any international speaker? Or someone who is not Polish and could say about the living experience in Poland as non Polish native?
- A Unfortunately, with this webinar we did not have guests that are not Polish, but the recordings of our previous webinars with guest appearances of POLONEZ Fellows who are non-Polish citizens are available on NCN's YouTube channel:

- Q It would be nice to meet with other POLONEZ fellows in biology, chemistry and physics to cooperate. Do you organize such meeting regularly?
- A We have a kick-off meeting planned for each group of Fellows recruited in three POLONEZ BIS calls, we are also planning to have a conference POLONEZ BIS Fellows' Forum in 2024 when all the Fellows are already in Poland. During the training sessions we are also going to organise special networking events. If POLONEZ BIS Fellows want to meet, this can always happen with or without NCN, as you please.



Technical issues – OSF system

- Q Please tell the correct option to choose while creating OSF Account. PhD holder can choose Philosphiae doctor to register themselves as rest options only either bachelor or other options.
- A While creating (registering) the account in the OSF system, you do not need to choose an academic degree/title (you may do so, but it is not required). However, while completing the Principal Investigator's details in the proposal, you should select your academic degree/title from the drop-down list. You may update both the OSF account details and the PI's details later on during project implementation.



Other

Q Do we need to submit NOC certificate if we are working?

A NCN does not require the No Objection Certificate. As far as we know Polish embassies or consulates do not require it either.
